### Assumptions:

1. Assumes parallel up/down shifts in the US Treasury yield curve, either instantaneously or gradually (in equally-spaced and equally-sized increments over a 12-month period).
2. Assumes credit spreads remain constant over the observation period.
3. 12-Mo Gradual Rate Shock assumes all cash flows from coupon income and principal repayments are reinvested at pre-determined forward interest rates specific to the dates of each cash flow.
4. 12-Mo Gradual Rate Shock assumes all remaining bonds are priced at month 12 using the spot curve.
