Prior to that date, the funds had no investment operations. Accordingly, the performance information shown for periods prior to that date is that of MDT All Cap Core Fund, MDT Large Cap Growth Fund and MDT Small Cap Growth Fund.

The MDT Large Cap Value Fund is the successor to the Federated MDT Large Cap Value Fund pursuant to a reorganization completed on December 8, 2017. The predecessor fund is both the tax and accounting survivor of the reorganization. The performance information, including information on fees and expenses and financial information provided above for periods prior to December 8, 2017 is historical information for the predecessor fund. The predecessor fund's A Shares commenced operations on May 1, 2014. The predecessor fund's IS Shares commenced operations on January 29, 2010. For the periods prior to the commencement of operations of the predecessor fund's A and IS Shares, the performance information is that of the predecessor fund's SS Shares. Accordingly, the performance information, including information on fees and expenses and financial information for periods prior to the reorganization (the fund's commencement of operations) is historical information for the Predecessor Fund.

The MDT Mid Cap Growth fund's Institutional Shares commenced operations on January 29, 2010. For the period prior to the commencement of operations for the Institutional Shares, the performance information shown is for the fund's A Shares. The performance of the A Shares has not been adjusted to reflect the expenses of the Institutional Shares since the Institutional Shares have a lower expense ratio than the expense ratio of the A Shares.
