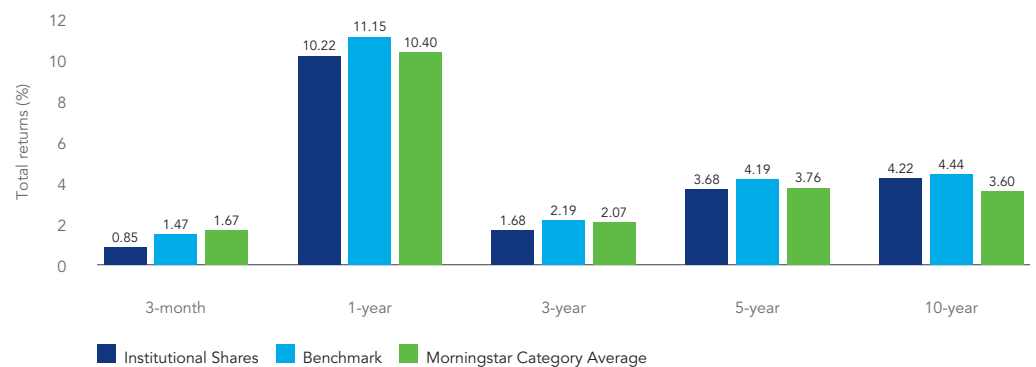
Fund description

The fund pursues a high level of current income by investing primarily in non-investment-grade corporate fixed-income securities issued by U.S. or foreign businesses. Such securities tend to perform at their best during economic recoveries and expansions, and can offer portfolio diversification as their performance historically is uncorrelated to other types of bonds.

Consistency of people

- Analysts are industry specialists responsible for researching the complex capital structures of high-yield companies and providing security recommendations to the portfolio managers.

Consistency of process

- A bottom-up process, focusing on strong operating companies that generate free cash flow in stable and predictable businesses.
- We hold a fundamentally different view of quality compared to the rating agencies. Our process includes: focus on franchise value, industry profile, competitive profile, strength of management, forward-looking view of company financials and a belief that the market is more efficient at pricing high-yield credit risk than the agencies.

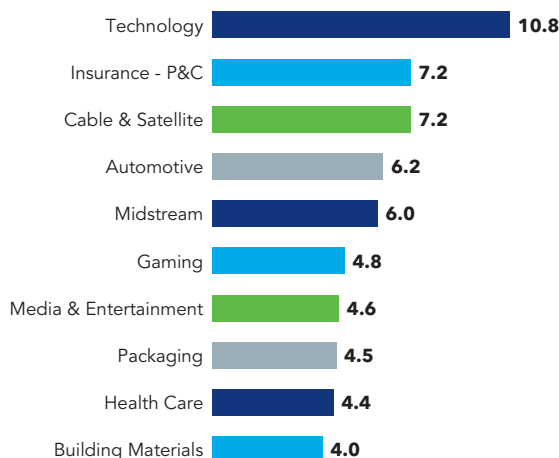

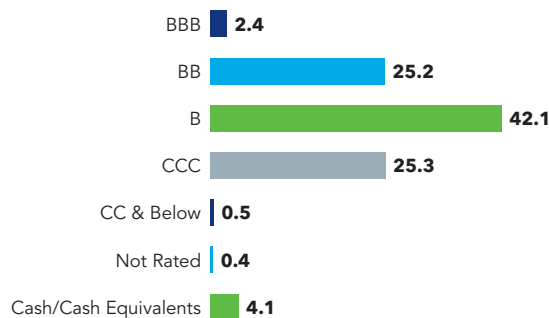

Market overview

For the three months ended March 31, 2024, the high yield market outperformed the investment grade bond market. The Bloomberg US Corporate High Yield 2% Issuer Capped Bond Index (BC2%HYBI) returned 1.47% versus a -0.78% return for the Bloomberg Aggregate Bond Index (Aggregate), a broad measure of high-quality bond performance.

The high yield market generated strong relative performance and solid absolute performance during the quarter. The resilient U.S. economy drove the relative performance. This supported corporate earnings, which, while not great, were enough to maintain credit protection measures. Also supporting high yield bonds was a general perception that the Federal Reserve (Fed) was done raising rates, and the next move would be a reduction in the fed funds rate. However, the strength of the economy led the market to reduce the number of rate cuts anticipated in 2024 and move the starting date for cuts to later in the year. This pushed U.S. Treasury rates modestly higher, negatively impacting the high-quality markets more than the high yield market, leading to strong relative performance for high yield. For example, the 5-year U.S. Treasury's yield increased 36 basis points during the period. However, this was more than offset by a decline in high yield credit spreads. The credit spread between the Credit Suisse High Yield Bond Index and Treasury securities with similar maturities began the quarter at 363 basis points and ended the quarter at 322 basis points.

Within the high yield market, the strongest performing major industry sectors relative to the BC2%HYBI were: Retailers, Health Care, Oil Field Services, Other Financials and Building Materials. The worst performing major industry sectors relative to the BC2%HYBI were: Wireless Telecommunications, Cable & Satellite, Media & Entertainment, Electric Utilities and Packaging. From a quality perspective, the more credit-sensitive CCC-rated sector led the way with a return of 2.14%, followed by the B-rated sector with a return of 1.36%. The more interest rate-sensitive BB-sector trailed with a 1.13% return.

Performance

The fund underperformed the BC2%HYBI. The fund was negatively impacted by security selection in the Media & Entertainment, Packaging, Midstream and Pharmaceutical industry sectors. The fund was also negatively impacted by its underweight in the Retail sector. Specific high yield issuers held by the portfolio that negatively impacted performance relative to the BC2%HYBI included: ARD Finance SA/Ardagh Packaging, CSC Holdings, iHeartCommunications, Terrier Media Buyer and Grifols Escrow Issuer. The fund's total return for the period also reflects actual cash flows, transaction costs and other expenses, which were not reflected in the total return of the BC2%HYBI.

The fund was positively impacted by security selection in the Building Materials and Consumer Cyclical Services industry sectors. The fund was also positively impacted by its underweight to the underperforming Wireless Telecommunications sector. Specific high yield issuers held by the portfolio that positively impacted performance relative to the BC2%HYBI included: SRS Distribution, Clydesdale Acquisition, Ardonagh Midco 2 PLC, Community Health Systems and Allied Universal Holdco.

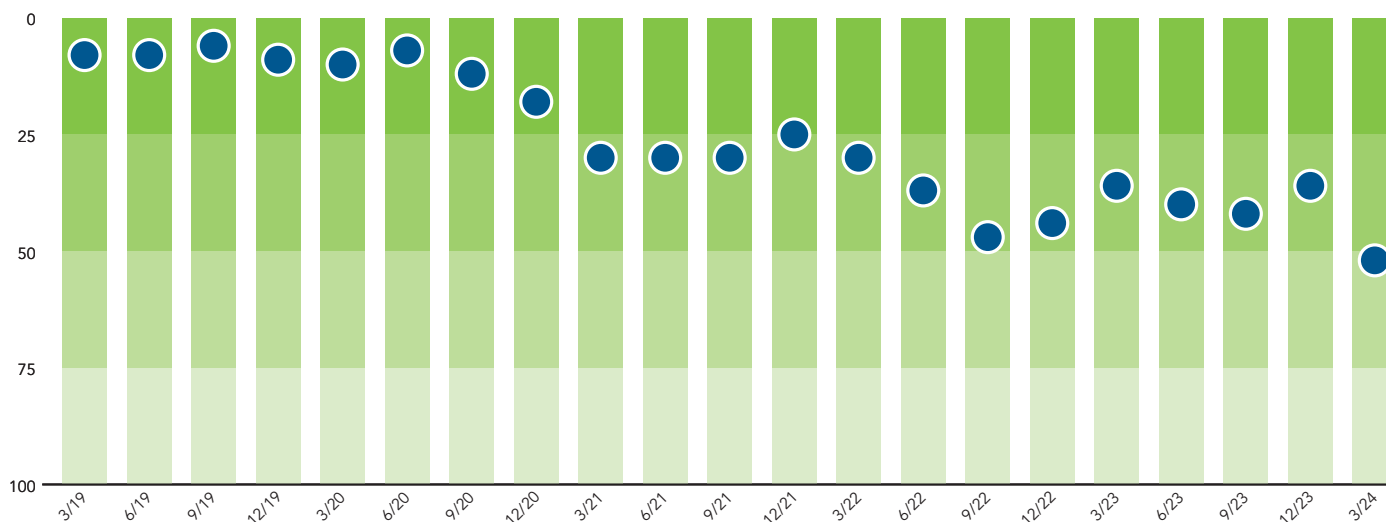

How we are positioned

The U.S. economy continues to deliver above expectation growth as illustrated by the 3+% 4th quarter GDP growth and current expectation of 2.8% for the first quarter of 2024, according to the Atlanta Fed's GDPNow forecast. However, credit spreads largely reflect this as the month-end spread of 322 basis points place them in the tightest 3% since 1986. Corporate operating performance is relatively stable, although many large industry sectors suffer from less than robust long-term secular outlooks, including Media & Entertainment, Retail, Wireline Telecommunications and Cable & Satellite. Also, higher interest expense driven by the increase in interest rates over the past few years continues to put stress on free cash flow measures. These factors lead us to remain somewhat cautious on high yield in the near term, as credit spreads remain too tight.

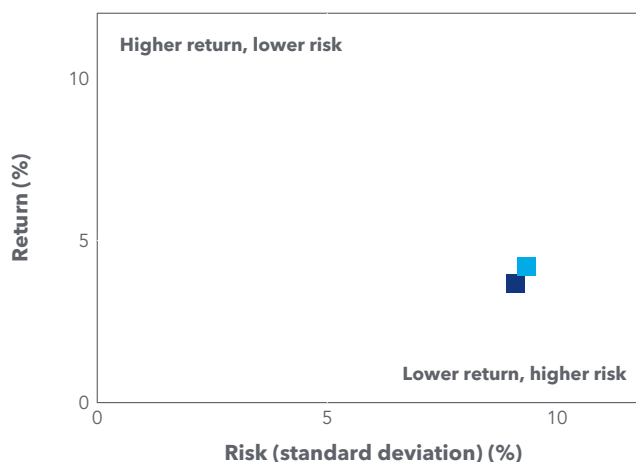

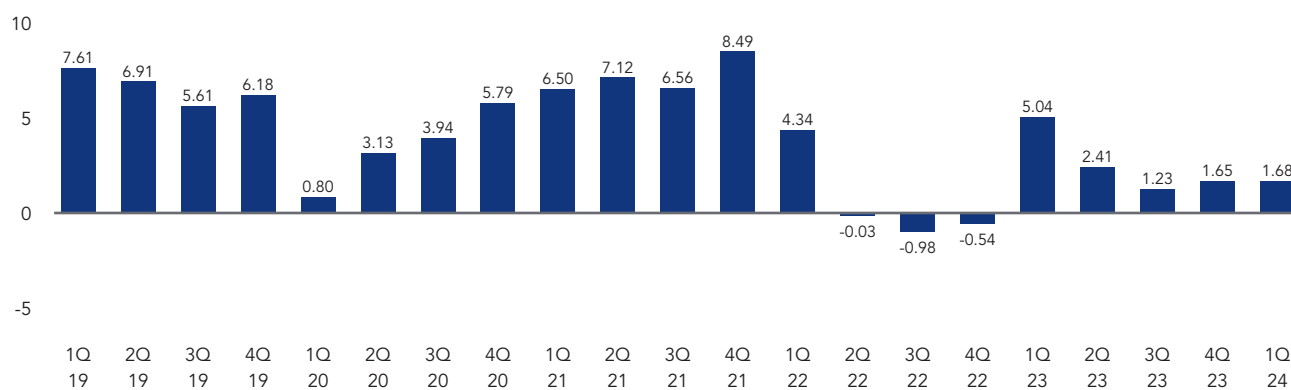

The fund's A Shares commenced operations on February 14, 2023. For the periods prior to commencement of operations of the fund's A Shares, the performance information shown is for the fund's Institutional Shares. The performance of the Institutional Shares has not been adjusted to reflect the expenses applicable to the A Shares. The performance has been adjusted to reflect the differences in sale charges and deferred sales charges applicable to the A Shares. The expense ratios of the A Shares will be higher than the expense ratio of the Institutional Shares; accordingly, for the periods prior to the commencement of operations, the performance of the A Shares would have been lower than the performance of the Institutional Shares.

¹The ratings agencies that provided the ratings are S&P Global Ratings, Moody's and Fitch. When ratings vary, the lowest rating is used. Credit ratings of A or better are considered to be high credit quality; credit ratings of BBB are good credit quality and the lowest category of investment grade; credit ratings BB and below are lower-rated securities ("junk bonds"); and credit ratings of CCC or below have high default risk. The credit quality breakdown does not give effect to the impact of any credit derivative investments made by the fund.

30-day yield (also known as "SEC yield") for A Shares is a compounded and annualized figure calculated according to a formula set by the SEC. The formula requires use of a specific methodology for calculating dividends and interest earned, and expenses accrued, during the period, and reflects the maximum offering price per fund share. The standardized computation is designed to facilitate yield comparisons among different funds. In the absence of temporary expense waivers or reimbursements, the 30-day yield would have been 6.43% at maximum offering price for A Shares, 7.04% for R6 Shares, and 7.00% for Institutional Shares.

The fund's R6 Shares commenced operations on June 30, 2016. For the period prior to the commencement of operations of the R6 Shares, the performance information shown is for Institutional Shares. The performance of the Institutional Shares has not been adjusted to reflect the expenses applicable to the R6 Shares since the R6 Shares have a lower expense ratio than the expense ratio of the Institutional Shares. The performance of the Institutional Shares has been adjusted to remove any voluntary waiver of fund expenses related to the Institutional Shares that may have occurred during the period prior to the commencement of operations of the R6 Shares.

A word about risk

High-yield, lower-rated securities generally entail greater market, credit/default and liquidity risks, and may be more volatile than investment-grade securities.

Bond prices are sensitive to changes in interest rates, and a rise in interest rates can cause a decline in their prices.

Definitions

Alpha shows how much or how little return is generated, given the risk a portfolio takes. A portfolio with an alpha greater than 0 has earned more than expected given its beta—meaning the portfolio has generated excess return without increasing risk. A portfolio with a negative alpha is producing a lower return than would be expected given its risk.

Beta measures a portfolio's volatility relative to the market. A beta greater than 1.00 suggests the portfolio has historically been more volatile than the market as measured by the fund's benchmark. A beta less than 1.00 suggests the portfolio has historically had less volatility relative to the market.

Sharpe ratio is calculated by dividing a fund's annualized excess return by the fund's annualized standard deviation. The higher the Sharpe ratio, the better the fund's historical risk adjusted performance.

Standard deviation is a historical measure of the variability of returns relative to the average annual return. A higher number indicates higher overall volatility.

Up capture ratio/down capture ratio is a measure of how well a manager was able to replicate or improve on periods of positive benchmark returns and how badly the manager was affected by periods of negative benchmark returns. The up-market capture ratio is a measure of a manager's performance in up markets relative to the index during the same period. For example, a ratio value of 115 indicates that the manager has outperformed the market index by 15% in periods when the index has risen. The down-market capture ratio is the direct opposite of the up-market capture ratio, gauging performance of the manager relative to the index in down markets. A ratio value of 80 would indicate the manager had declined on 80% as much as the declining overall market, indicating relative outperformance.

Weighted average bond price is the weighted average of all individual bond prices within a portfolio.

Weighted average coupon is the weighted average interest payment of all individual debt securities within a portfolio.

Weighted average duration to worst is the approximate percentage change in a bond's price given a 1% change in its yield-to-maturity or its yield-to-call, whichever is lower. Duration-to-Worst is the same as Macaulay's duration except the pre-determined set of principal and interest cash flows are based on either the final maturity date, or a call date within the bond's call schedule, whichever would result in the lowest yield to the investor – i.e., the Yield-to-Worst.

Weighted average effective maturity is the average time to maturity of debt securities held in the fund.

Weighted average yield to worst is an average of the lowest potential yield that can be received on a bond without the issuer actually defaulting. The yield to worst is calculated by making worst-case scenario assumptions on the issue by calculating the returns that would be received if provisions, including prepayment, call or sinking fund, are used by the issuer.

Bloomberg US Aggregate Bond Index is an unmanaged index composed of securities from the Bloomberg Government/Corporate Bond Index, the Mortgage-Backed Securities Index and the Asset-Backed Securities Index. Total return comprises price appreciation/depreciation and income as a percentage of the original investment. Indices are rebalanced monthly by market capitalization.

Bloomberg US Corporate High Yield 2% Issuer Capped Index is an issuer-constrained version of the flagship US Corporate High Yield Index, which measures the USD-denominated, high yield, fixed-rate corporate bond market. The index follows the same rules as the uncapped version, but limits the exposure of each issuer to 2% of the total market value and redistributes any excess market value index wide on a pro rata basis. The index was created in 2002, with history backfilled to January 1, 1993.
