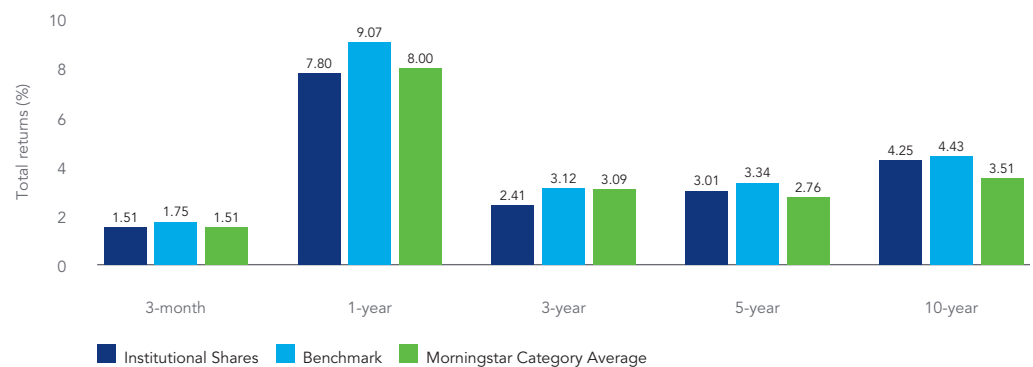
Fund description

The fund pursues a high level of current income by investing primarily in non-investment-grade corporate fixed-income securities issued by U.S. or foreign businesses. Such securities tend to perform at their best during economic recoveries and expansions, and can offer portfolio diversification as their performance historically is uncorrelated to other types of bonds.

Investment approach

Consistency of people

- The high-yield team is comprised of 16 investment professionals with an average of 20 years of investment experience, 13 of 16 team members have more than 10 years of experience, the vast majority of experience earned on the Federated Hermes high-yield team.
- Analysts are industry specialists responsible for researching the complex capital structures of high-yield companies and providing security recommendations to the portfolio managers.

Consistency of process

- A bottom-up process, focusing on strong operating companies that generate free cash flow in stable and predictable businesses.
- We hold a fundamentally different view of quality compared to the rating agencies. Our process includes: focus on franchise value, industry profile, competitive profile, strength of management, forward-looking view of company financials and a belief that the market is more efficient at pricing high-yield credit risk than the agencies.

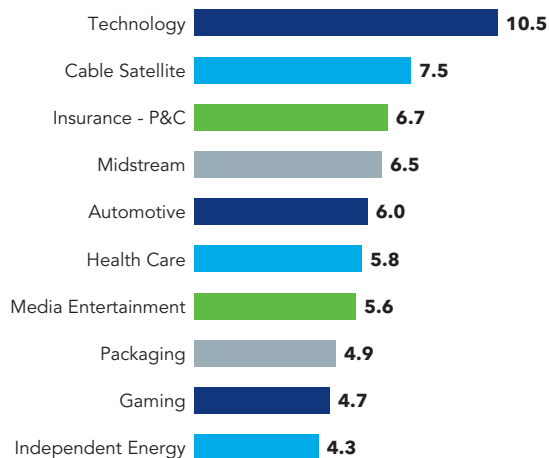

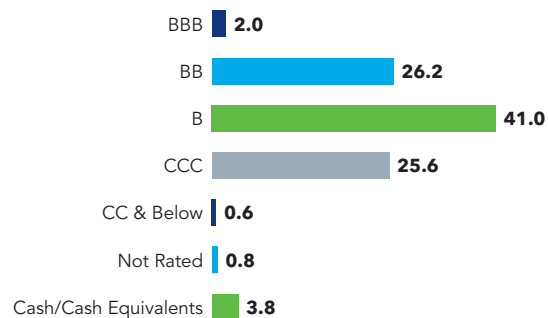

Market overview

For the three months ended June 30, 2023, the high yield market outperformed the investment-grade bond market. For example, the Bloomberg U.S. Corporate High Yield 2% Issuer Capped Bond Index (BC2%HYBI) returned 1.75% versus a 0.84% return for the Bloomberg Aggregate Bond Index (Aggregate), a measure of high-quality bond performance.

The high yield market turned in another strong quarter of relative performance versus high quality fixed income assets as a contraction in credit spreads offset most of the 58 basis point increase in the interest rate on a 5-year U.S. Treasury. While many high yield companies have seen earnings decline from peak levels, the deterioration has been relatively modest given the substantial increase in short-term interest rates orchestrated by global central banks in order to slow inflation. While many forward-looking indicators of the economy have weakened, current conditions remain adequate to support high yield issuers' credit profiles. Default rates have continued to move higher but remain below long-term averages. New issuance of high yield securities increased relative to recent quarters but remains below average. The overall movement in credit spreads can be illustrated by the change in spreads between the Credit Suisse High Yield Bond Index and Treasury securities with similar maturities, which began the period at 480 bps, reached a high point of 520 bps on May 4 and then declined to a low of 425 bps on June 30.

Within the high yield market, the strongest performing major industry sectors relative to the BC2%HYBI were: Retail, Leisure, Wirelines Telecommunication, Industrial-other and Building Materials. The worst performing major industry sectors relative to the BC2%HYBI were: Wireless Telecommunications, Banking, Electric Utilities, Financial-others and Food & Beverage. From a quality perspective, the CCC-rated sector led the way with a return of 4.18% followed by the B-rated sector at 1.90%. The more interest rate sensitive BB-rated sector brought up the rear with a return of 0.88%.

Performance

The fund underperformed the BC2%HYBI. The fund was negatively impacted by security selection in the Media & Entertainment, Cable & Satellite, Electric Utility and Finance Company industry sectors. The fund was also negatively impacted by its underweight to the strong performing Leisure, Retail and Wireline Telecommunication sectors. Specific high yield issuers held by the portfolio that negatively impacted performance relative to the BC2%HYBI included: Enviva, CSC Holdings, Global Medical Response, iHeartCommunications and Rackspace Technology. The fund's total return for the period also reflects actual cash flows, transaction costs and other expenses that were not reflected in the total return of the BC2%HYBI.

The fund was positively impacted by security selection in the Technology, Packaging, Automotive, Consumer Cyclical Services and Independent Energy industry sectors. The fund was also positively impacted by its overweight to the strong performing P&C Insurance (brokers) and Building Material sectors and its underweight to the poor performing Wireless Telecommunications sector. Specific high yield issuers held by the portfolio that positively impacted performance relative to the BC2%HYBI included: Dornoch Debt Merger Sub, Ardagh Packaging Finance, EQM Midstream Partners, Real Hero Merger Sub and Bausch Health.

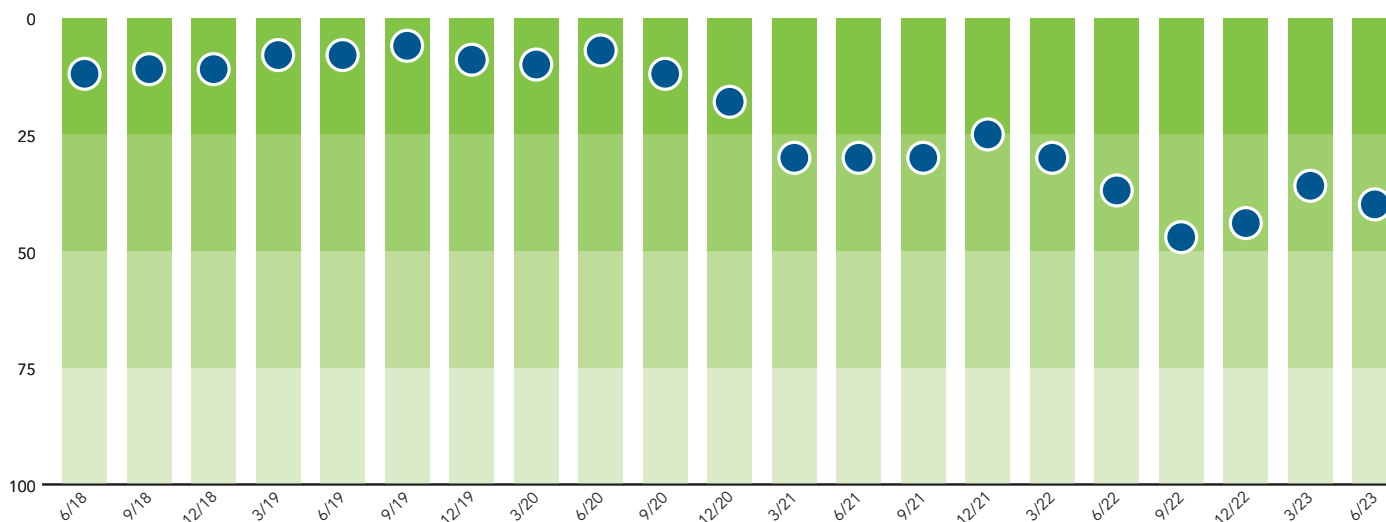

How we are positioned

Despite the strong year-to-date performance of the high yield market, we continue to be somewhat concerned about the second half of 2023. Many leading economic indicators point to a weakening of overall economic activity. We believe earnings will continue to decline as volume weakness persists and companies' ability to raise or maintain prices declines resulting in weaker margins. We believe defaults will continue to move higher and downgrades will increase relative to upgrades. Also, it appears that global short rates will continue to move higher as central banks attempt to slow economic growth to combat persistent high inflation. These factors should push spreads higher. The major offset to these factors remains a continuing robust jobs environment, which is providing consumers with ample liquidity to keep the economy generating stronger-than-expected economic growth.

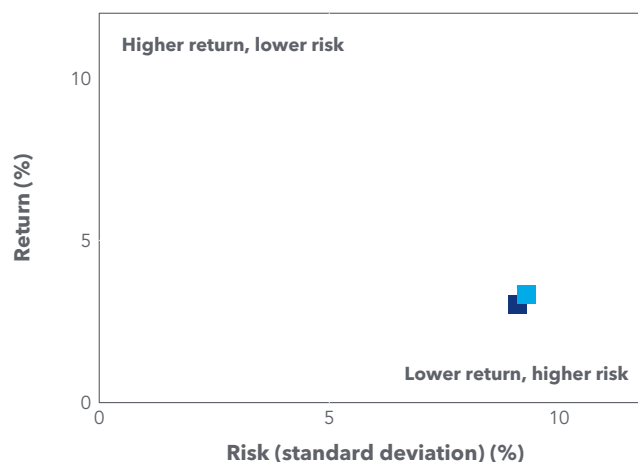

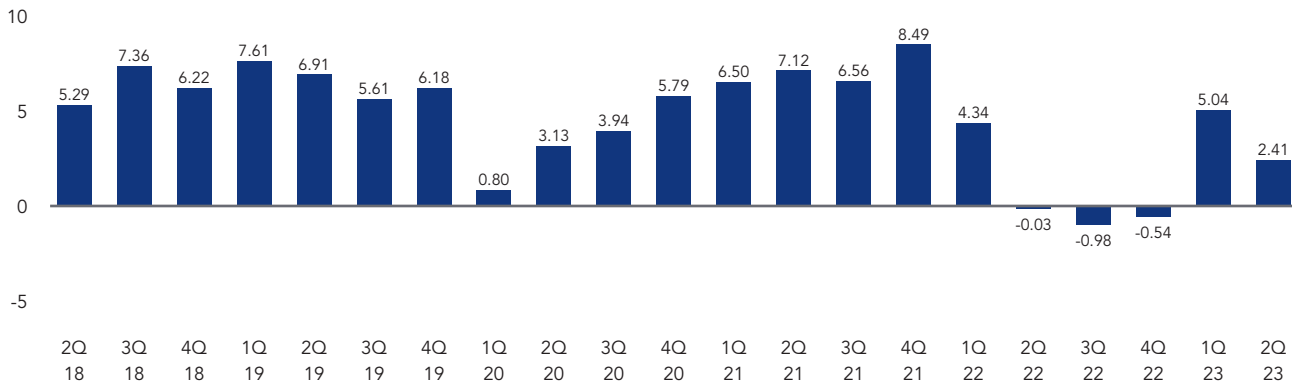

Federated Hermes Institutional High Yield Bond Fund

The fund's A Shares commenced operations on February 14, 2023. For the periods prior to commencement of operations of the fund's A Shares, the performance information shown is for the fund's Institutional Shares. The performance of the Institutional Shares has not been adjusted to reflect the expenses applicable to the A Shares. The performance has been adjusted to reflect the differences in sale charges and deferred sales charges applicable to the A Shares. The expense ratios of the A Shares will be higher than the expense ratio of the Institutional Shares; accordingly, for the periods prior to the commencement of operations, the performance of the A Shares would have been lower than the performance of the Institutional Shares.

¹The ratings agencies that provided the ratings are Standard & Poor's, Moody's and Fitch. When ratings vary, the lowest rating is used. Credit ratings of A or better are considered to be high credit quality; credit ratings of BBB are good credit quality and the lowest category of investment grade; credit ratings BB and below are lower-rated securities ("junk bonds"); and credit ratings of CCC or below have high default risk. The credit quality breakdown does not give effect to the impact of any credit derivative investments made by the fund.

30-day yield (also known as "SEC yield") for A Shares is a compounded and annualized figure calculated according to a formula set by the SEC. The formula requires use of a specific methodology for calculating dividends and interest earned, and expenses accrued, during the period, and reflects the maximum offering price per fund share. The standardized computation is designed to facilitate yield comparisons among different funds. In the absence of temporary expense waivers or reimbursements, the 30-day yield would have been 7.46% at maximum offering price for A Shares, 8.13% for R6 Shares, and 8.09% for Institutional Shares.

The fund's R6 Shares commenced operations on June 30, 2016. For the period prior to the commencement of operations of the R6 Shares, the performance information shown is for Institutional Shares. The performance of the Institutional Shares has not been adjusted to reflect the expenses applicable to the R6 Shares since the R6 Shares have a lower expense ratio than the expense ratio of the Institutional Shares. The performance of the Institutional Shares has been adjusted to remove any voluntary waiver of fund expenses related to the Institutional Shares that may have occurred during the period prior to the commencement of operations of the R6 Shares.

A word about risk

High-yield, lower-rated securities generally entail greater market, credit/default and liquidity risks, and may be more volatile than investment-grade securities.

Bond prices are sensitive to changes in interest rates, and a rise in interest rates can cause a decline in their prices.

Definitions

Alpha shows how much or how little return is generated, given the risk a portfolio takes. A portfolio with an alpha greater than 0 has earned more than expected given its beta—meaning the portfolio has generated excess return without increasing risk. A portfolio with a negative alpha is producing a lower return than would be expected given its risk.

Beta measures a portfolio's volatility relative to the market. A beta greater than 1.00 suggests the portfolio has historically been more volatile than the market as measured by the fund's benchmark. A beta less than 1.00 suggests the portfolio has historically had less volatility relative to the market.

Sharpe ratio is calculated by dividing a fund's annualized excess return by the fund's annualized standard deviation. The higher the Sharpe ratio, the better the fund's historical risk adjusted performance.

Standard deviation is a historical measure of the variability of returns relative to the average annual return. A higher number indicates higher overall volatility.

Up capture ratio/down capture ratio is a measure of how well a manager was able to replicate or improve on periods of positive benchmark returns and how badly the manager was affected by periods of negative benchmark returns. The up-market capture ratio is a measure of a manager's performance in up markets relative to the index during the same period. For example, a ratio value of 115 indicates that the manager has outperformed the market index by 15% in periods when the index has risen. The down-market capture ratio is the direct opposite of the up-market capture ratio, gauging performance of the manager relative to the index in down markets. A ratio value of 80 would indicate the manager had declined on 80% as much as the declining overall market, indicating relative outperformance.

Weighted average bond price is the weighted average of all individual bond prices within a portfolio.

Weighted average coupon is the weighted average interest payment of all individual debt securities within a portfolio.

Weighted average duration to worst is the approximate percentage change in a bond's price given a 1% change in its yield-to-maturity or its yield-to-call, whichever is lower. Duration-to-Worst is the same as Macaulay's duration except the pre-determined set of principal and interest cash flows are based on either the final maturity date, or a call date within the bond's call schedule, whichever would result in the lowest yield to the investor – i.e., the Yield-to-Worst.

Weighted average effective maturity is the average time to maturity of debt securities held in the fund.

Weighted average yield to worst is an average of the lowest potential yield that can be received on a bond without the issuer actually defaulting. The yield to worst is calculated by making worst-case scenario assumptions on the issue by calculating the returns that would be received if provisions, including prepayment, call or sinking fund, are used by the issuer.

Bloomberg US Aggregate Bond Index is an unmanaged index composed of securities from the Bloomberg Government/Corporate Bond Index, the Mortgage-Backed Securities Index and the Asset-Backed Securities Index. Total return comprises price appreciation/depreciation and income as a percentage of the original investment. Indices are rebalanced monthly by market capitalization.

Bloomberg US Corporate High Yield 2% Issuer Capped Index is an issuer-constrained version of the flagship US Corporate High Yield Index, which measures the USD-denominated, high yield, fixed-rate corporate bond market. The index follows the same rules as the uncapped version, but limits the exposure of each issuer to 2% of the total market value and redistributes any excess market value index wide on a pro rata basis. The index was created in 2002, with history backfilled to January 1, 1993.
