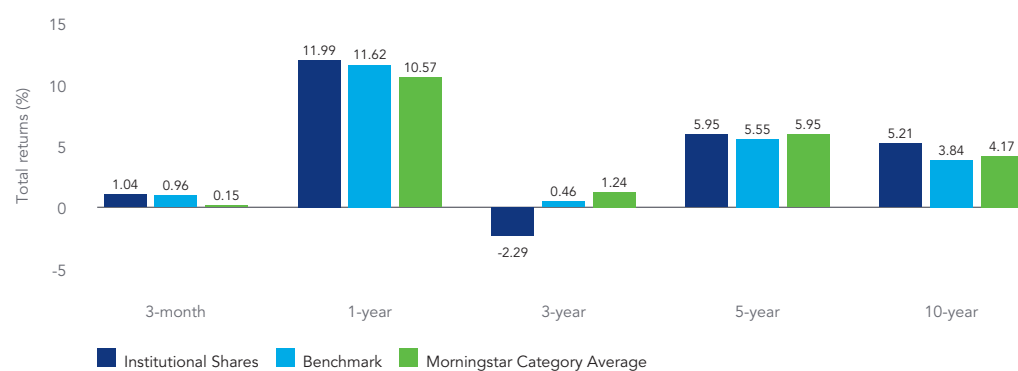
Fund description

The fund seeks long-term capital appreciation by investing primarily in equity securities that are tied to numerous countries throughout the world in both developed and emerging markets. Employing a top-down approach to country selection and a bottom-up security selection process, the fund may invest in companies of any capitalization, and its allocation is typically split between growth and value stocks.

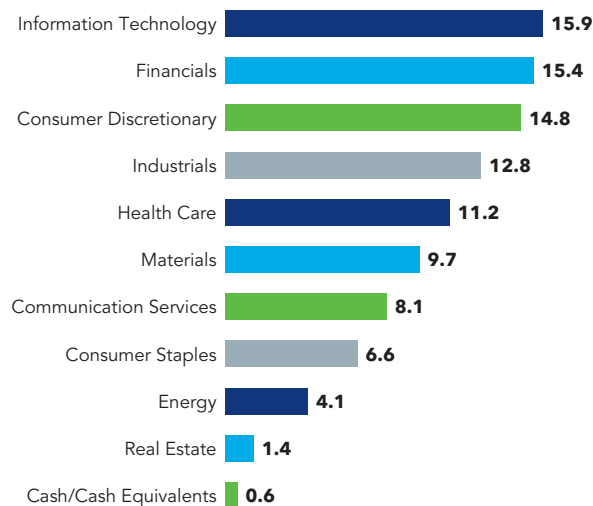

Highlights

- International stock markets underperformed relative to the U.S. as developed markets underperformed even as the emerging markets outperformed
- Volatility briefly spiked in April due to conflict between Iran and Israel but investor sentiment recovered in the absence of meaningful escalation with investors returning to the AI theme
- The U.S. dollar strengthened during the quarter
- Commodities were mixed as metals and natural gas prices gained while oil prices traded sideways
- Internationally, value outperformed growth
- The Federated Hermes International Equity Fund performed in line with its benchmark as the growth sleeve's outperformance offset the value sleeve's underperformance

Looking back

Iran's direct attack on Israel rekindled fears of escalating violence in the Middle East and initially drove higher oil prices and an increase in volatility. Fortunately, both the attack and Israel's subsequent countermeasure caused minimal damage. Markets broadly bounced back after the conflict appeared contained. Despite sticky U.S. inflation and growing expectations for higher-for-longer interest rates in the U.S., the AI theme continued to provide support. Globally, most central banks remained on hold in the quarter.

Overall, these trends led to the outperformance of tech and momentum while consumer discretionary fared the worst. In a reversal from the prior two quarters, emerging markets outperformed developing. Tech giant TSMC drove another strong quarter in Taiwan while Indian markets continued to benefit from persistent economic strength and foreign investment, recovering after initial disappointment from Prime Minister Modi's party winning fewer parliamentary seats. After four quarters of underperformance, China outperformed and rebounded from multiyear lows, even as a weak property market remained a headwind. Mexico underperformed due to a stronger than expected vote tally for the Morena party. Japan was the worst-performing market due to the rapidly weakening yen which drove the Japanese Ministry of Finance to intervene twice in its defense. France also lagged as investors fled from rising political risk due to President Macron calling for snap elections.

Performance

The Federated Hermes International Equity Fund returned 1.0% (Institutional Shares at NAV) for the quarter ending June 30, 2024. That compares to its benchmark, the MSCI ACWI ex USA index, which returned 1.0% during the period.

Performance contributors

- Positive country allocation effects came from overweights to Norway and Argentina along with an underweight to Mexico.
- Positive sector allocation effects came from overweights to Health Care and Information Technology along with an underweight to Consumer Staples.

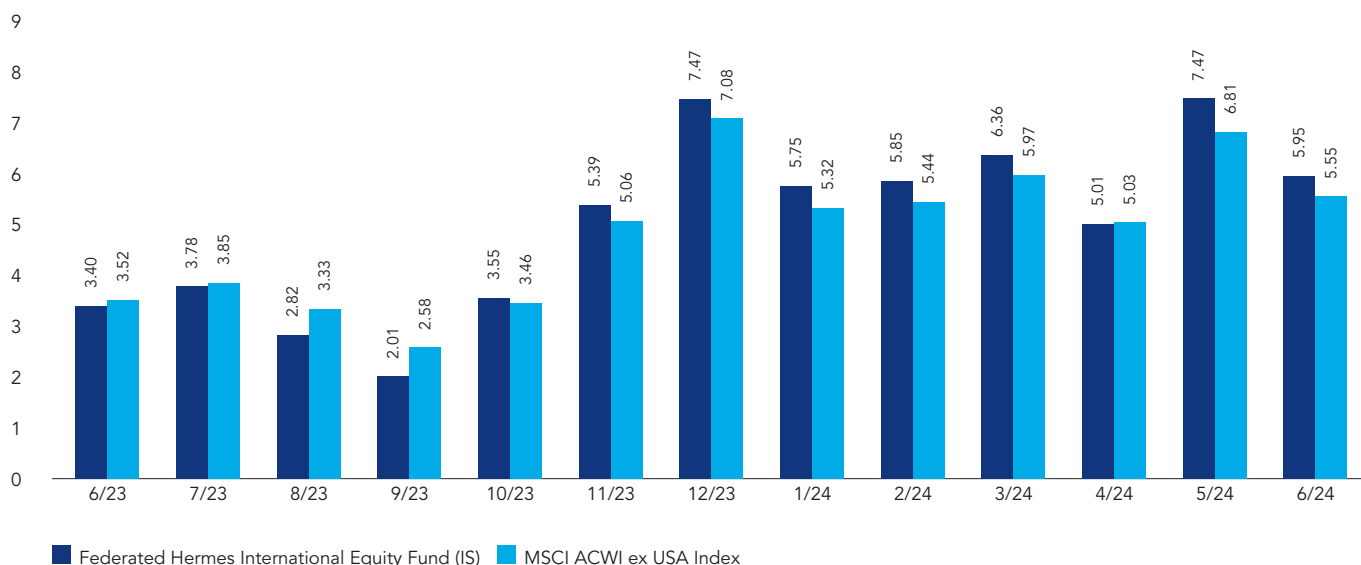
Performance detractors

- Negative country allocation effects came from an overweight to Ireland along with underweights to Taiwan and India
- Negative sector allocation effects came from overweights to Consumer Discretionary and Materials along with an underweight to Financials

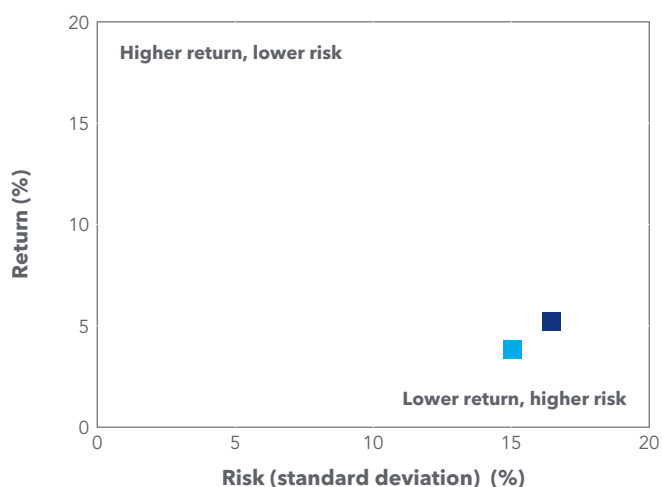

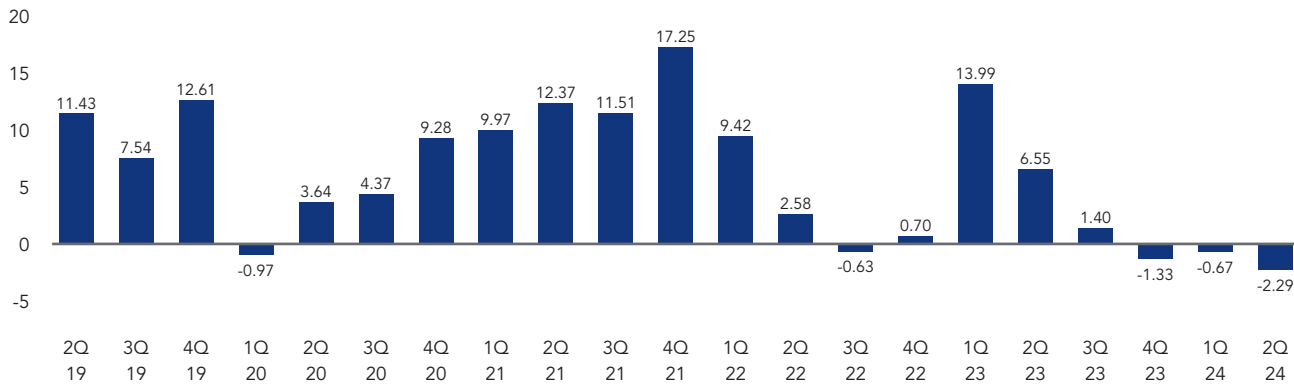

The fund is the successor to the PNC International Equity Fund ("predecessor fund"), a portfolio of PNC Funds, pursuant to a reorganization involving the Fund and the predecessor fund on November 15, 2019. Prior to the date of the reorganization, the fund had no investment operations. Accordingly, the performance information, for periods prior to the reorganization is historical information for the predecessor fund. The predecessor fund was managed by the same portfolio management team as the fund, had an identical investment objective and substantially identical strategies, policies and restrictions.

Definitions

Beta measures a portfolio's volatility relative to the market. A beta greater than 1.00 suggests the portfolio has historically been more volatile than the market as measured by the fund's benchmark. A beta less than 1.00 suggests the portfolio has historically had less volatility relative to the market.

Correlation is the degree to which one variable (here, the fund's returns) fluctuates relative to another (the returns of the fund's benchmark). Correlation ranges from 1.00, when two variables move identically in the same direction, to -1.00, when two variables move identically in the opposite direction.

Standard deviation is a historical measure of the variability of returns relative to the average annual return. A higher number indicates higher overall volatility.

Up capture ratio/down capture ratio is a measure of how well a manager was able to replicate or improve on periods of positive benchmark returns and how badly the manager was affected by periods of negative benchmark returns. The up-market capture ratio is a measure of a manager's performance in up markets relative to the index during the

same period. For example, a ratio value of 115 indicates that the manager has outperformed the market index by 15% in periods when the index has risen. The down-market capture ratio is the direct opposite of the up-market capture ratio, gauging performance of the manager relative to the index in down markets. A ratio value of 80 would indicate the manager had declined on 80% as much as the declining overall market, indicating relative outperformance.

Weighted median P/E (NTM—next 12 months) is a ratio comparing share price to earnings-per-share using estimated data for the next 12 months.

Weighted median market cap is the calculation representing the median market capitalization of the stocks in the portfolio, weighted by the amount of each stock.

Weighted median price/book is a ratio comparing share price to book value or assets minus liabilities.

MSCI ACWI ex USA Index captures large- and mid-cap representation across 22 of 23 developed markets (DM) countries (excluding the U.S.) and 27 emerging markets (EM) countries. The index covers approximately 85% of the global equity opportunity set outside the U.S.
