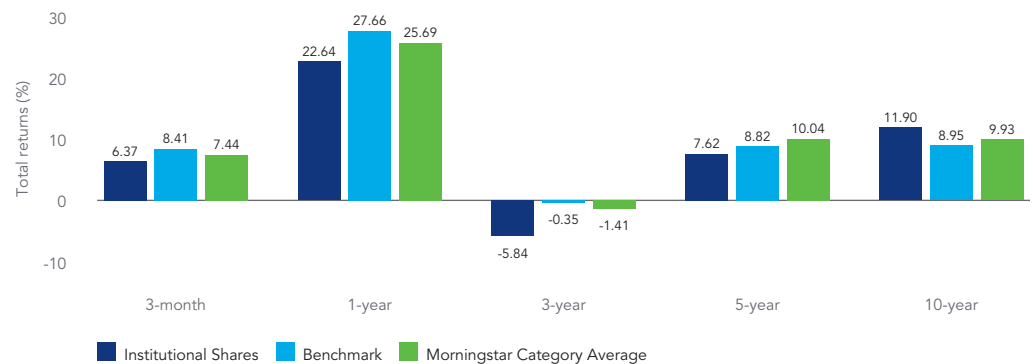
Fund description

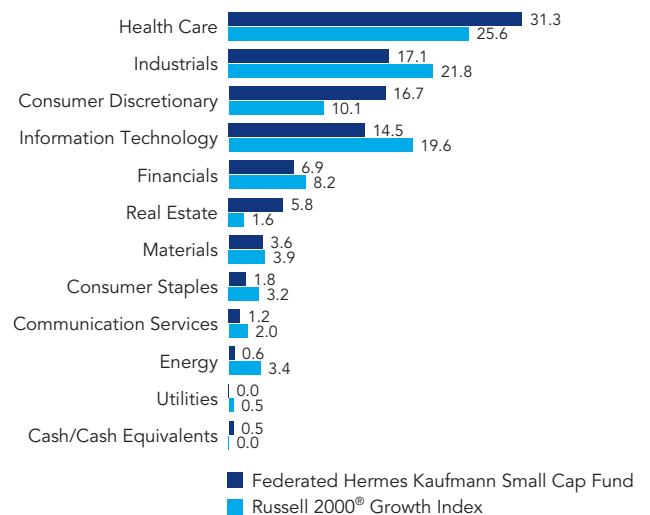

Highlights

- Global equity markets were positive during the quarter as central banks began lowering rates as inflation slowed globally
- Growth stocks underperformed value stocks during the quarter reversing the trend
- Stock selection hurt performance while sector weighting helped relative outperformance
- The Technology and Industrials sectors both negatively contributed to the fund's performance on a relative basis

Looking back

During the third quarter, the US economy and most significant Western economies saw economic growth moderate slightly. Inflation has continued to moderate at a tepid pace as fiscal stimuli slowed and geopolitical issues seem contained. The global inflationary pressures easing are enabling central banks to reverse their monetary tightening policies and begin an easing path going forward. The bond markets have begun to price in lower relative rates and a more dovish Federal Reserve stance has boosted US and global equities this year. The US indexes that were up the most during the last quarter were smaller cap stocks represented by the Russell 2000 Index returning 9.27%, followed by mid cap stocks represented by the Russell Mid Cap Index returning 9.21%, followed by biotech represented by the S&P Biotech Index returning 6.59%, followed by large cap companies represented by the Russell 1000 Index returning 6.08%, followed by the S&P 500 Index returning 5.89%, finally followed by the technology-heavy NASDAQ composite returning 2.76%. Small-cap growth stocks underperformed small-cap value stocks during the quarter.

During the quarter, the portfolio team added new positions of the following equity positions to the portfolio: Abercrombie & Fitch Co, Six Flags Entertainment Corp (new), Immunovant Inc (new), Procept BioRobotics Corp (new), Phathom Pharmaceuticals, Inc (new), Zenas Biopharma (IPO), FTAL Aviation Ltd (new), Onestream Inc (IPO) and Rubrik Inc (new).

During the quarter, the portfolio exited or reduced the following equity positions in pursuit of better opportunities: Morphic Holdings Inc, HashiCorp Inc, DexCom Inc, Veeva Systems Inc and Merus NV.

Capital Markets activities during the quarter:

The small cap fund participated in two IPOs in the quarter as the IPO market remained in recovery mode from the 2021 record year but showing some signs of recovery: Onesteam Inc and Zenas Biopharma Inc.

The team was active in the secondary equity markets during the quarter. The fund participated in five secondary offerings during the quarter: Ideaya Biosciences Inc, Allegro Microsystems Inc, Viking Holdings Ltd, Centessa Pharmaceuticals Ltd and Moncler SPA.

Performance

Federated Hermes Kaufmann Small Cap Fund (Institutional Shares) returned 6.37% at NAV in the third quarter. That compares with its benchmark the Russell 2000 Growth Index which returned 8.41% during the same period.

How we are positioned

As the US economy enters the last quarter of 2024, many headwinds have turned to tailwinds, such as Central Banks' rotating from tightening monetary policy to easing. While there is some encouraging macro momentum, there are persistent worries such as global elections, geopolitical uncertainty and rising oil prices. These questions are likely to endure, which could cause market uncertainty. One indicator of investor caution would be the continued quiet IPO activity since the peak in 2021. After a record-breaking year in 2021, the US IPO issuance remained quiet with 71 IPOs priced in 2022. In 2023, the market showed some signs of recovery with 108 IPOs raising \$20 billion according to Renaissance Capital. That IPO momentum has continued into the third quarter with 106 IPOs pricing in the US, raising \$24.7 billion. Despite the macro uncertainties, the Kaufmann team continues to focus on its goal of finding and investing in companies that have little dependence on the economy, good or bad, to generate significant sales and earnings growth.

This quarter the fund had approximately 78% of the portfolio invested in four sectors: Information Technology, Health Care, Consumer and Industrials. The sector weightings of the portfolio are a byproduct of our bottom-up stock selection strategy with a team of sector-specialist portfolio managers. These sectors have historically provided good opportunities for bottom-up growth investors. We seek to find companies that have company-specific catalysts for growth rather than develop macro themes to construct sector weightings. The strategy's consistent growth bias has allowed the portfolio to produce the following statistics: average sales growth last twelve months 25%, operating margins of 19% and median earnings growth for the last year of 18%. This compares to the Russell 2000 Growth Index, with average sales growth of 23%, median operating margins of 14% and median earnings growth of 20%.

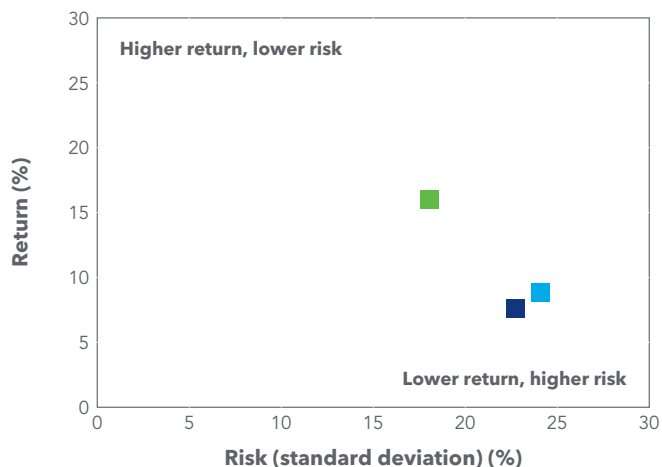

Fund vs. Russell 2000[®] Growth Index

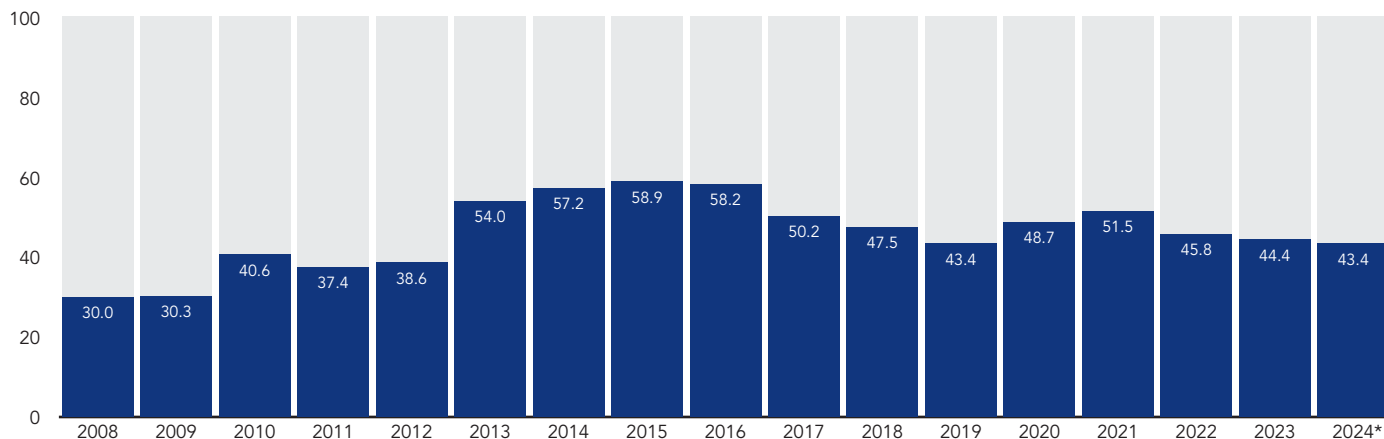

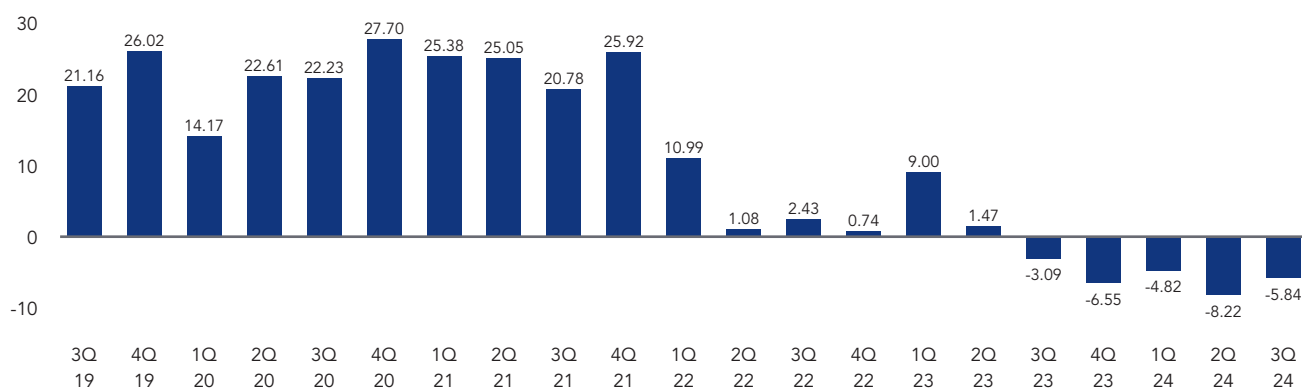
Percent of portfolio invested in IPOs (%)

Definitions

Alpha shows how much or how little return is generated, given the risk a portfolio takes. A portfolio with an alpha greater than 0 has earned more than expected given its beta—meaning the portfolio has generated excess return without increasing risk. A portfolio with a negative alpha is producing a lower return than would be expected given its risk.

Beta measures a portfolio's volatility relative to the market. A beta greater than 1.00 suggests the portfolio has historically been more volatile than the market as measured by the fund's benchmark. A beta less than 1.00 suggests the portfolio has historically had less volatility relative to the market.

R-squared indicates what percentage of a portfolio's movement in performance is explained by movement in performance of the market. R-squared ranges from 0 to 100, and a score of 100 suggests that all movements of a portfolio's performance are completely explained by movements in the market as measured by the fund's benchmark.

Standard deviation is a historical measure of the variability of returns relative to the average annual return. A higher number indicates higher overall volatility.

Weighted median P/E (LTM—latest 12 months) is a ratio comparing share price to earnings per share using data from the previous 12 months.

Weighted median P/E (NTM—next 12 months) is a ratio comparing share price to earnings-per-share using estimated data for the next 12 months.

Weighted median market cap is the calculation representing the median market capitalization of the stocks in the portfolio, weighted by the amount of each stock.

Russell 1000® Index measures the performance of the large-cap segment of the US equity universe. It is a subset of the Russell 3000® Index and includes approximately 1000 of the largest securities based on a combination of their market cap and current index membership. The Russell 1000® represents approximately 92% of the US market. The

Russell 1000® Index is constructed to provide a comprehensive and unbiased barometer for the large-cap segment and is completely reconstituted annually to ensure new and growing equities are reflected.

Russell 2000® Growth Index measures the performance of the small-cap growth segment of the US equity universe. The Russell 2000® Growth Index is constructed to provide a comprehensive and unbiased barometer for the small-cap growth segment. The Index is completely reconstituted annually to ensure larger stocks do not distort the performance and characteristics of the true small-cap opportunity set and that the represented companies continue to reflect growth characteristics.

Russell 2000® Index measures the performance of the small-cap segment of the US equity universe. The Russell 2000 is a subset of the Russell 3000® Index representing approximately 10% of the total market capitalization of that index. It includes approximately 2000 of the smallest securities based on a combination of their market cap and current index membership.
