14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► **On September 22, 2017, pursuant to a plan of reorganization within the meaning of IRC Section 368(a),**

(1) **all or substantially all of the assets of Federated Prudent DollarBear Fund (the Reorganizing Fund) were transferred in exchange solely for the shares of Federated Global Total Return Bond Fund (the Surviving Fund),**

(2) **Federated Global Total Return Bond Fund's shares were distributed to holders of the outstanding shares of Federated Prudent DollarBear Fund and**

(3) **Federated Prudent DollarBear Fund was liquidated and dissolved.**

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► **Due to the tax free status of this reorganization, Federated Prudent DollarBear Fund shareholders' aggregate basis for the Federated Global Total Return Bond Fund shares received remains the same as the aggregate basis of their Federated Prudent DollarBear shares exchanged. The per share basis, however, will change due to the differing number of shares received. This change will be calculated based on the relative fair market value of the two funds as of the date of the reorganization.**

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ► **For each tax lot held in Federated Prudent DollarBear Fund, the change in tax basis will be calculated by multiplying its cost basis, as of the date of the reorganization, by an adjustment factor.**

The resulting amount represents the adjusted per share tax basis. The holding period of all shares received includes the period that the exchanged Federated Prudent DollarBear Fund shares were held.
