14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On May 16, 2014, the Federated Ohio Municipal Income Fund ("Acquiring" Fund) acquired all of the assets of the issuer solely in exchange for shares of beneficial interest (see details below). The merger of the Huntington Funds - Huntington Ohio Tax-Free Fund ("Target Fund") into the Federated Ohio Municipal Income Fund ("Acquiring Fund") qualifies as a tax-free reorganization under IRC Section 368(a)(1)(c). The "Target" shareholders' total basis in the "Acquiring" shares received is the same as their total basis in the old "Target" shares. The exchange is based on the number and value of shares outstanding at the close of business on May 16, 2014.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ A shareholder's aggregate basis in the "Acquiring" Fund they received in exchange for their shares of the "Target Fund" will be the same as their aggregate basis in the shares of the "Target" Fund. The number of "Acquiring" Fund shares received for each share of the "Target" Fund is as follows:

1.911939502 shares of the Federated Ohio Municipal Income Fund - A Shares ("Acquirer") for one share of Huntington Ohio Tax-Free Fund - Class A Shares

1.912900356 shares of the Federated Ohio Municipal Income Fund - A Shares ("Acquirer") for one share of Huntington Ohio Tax-Free Fund - Institutional Shares

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ There was no change in the aggregate basis as a result of the above described organizational action.
